1. The S&W Race Cars in-house contingency program pays reward "credits" to the winner and runner-up at all 2009 NHRA national & divisional events, all IHRA national & divisional events and at selected "big money" bracket races throughout the year. Registered participants in the S&W Race Cars 2009 in-house contingency program will be eligible for credits of \$100.00 for each win and \$50.00 for each runner-up. Contingency will be accepted on the use of any complete S&W race car or the use of S&W chassis & suspension components or an S&W roll bar or roll cage. Reward will be redeemed at the competitors "regular" price level and carry NO cash value.
2. Registration for this program is required to be eligible for the rewards. Contingency sign up forms are available on our website at [www.swracecars.com](http://www.swracecars.com).
3. S&W Race Cars contingency decals are included with this info packet and must be placed on the car in an unobstructed location that is visible when the vehicle is viewed from the side. Placement behind the rear wheel well will not be accepted if the decal is obstructed by rubber from the burnout and placement on the inside of any wing or spoiler spill plate will also not be accepted. Decal trimming is not allowed.
4. Registrants are responsible for providing verified results to S&W Race Cars. Simply email the name and date of the event and the class of competition as well as a photo of the car showing the placement of the S&W contingency decal to [contingency@swracecars.com](mailto:contingency@swracecars.com). Registered participants submissions will be reviewed by our staff and all photos become the property of S&W Race Cars where they may be used for promotional purposes. S&W Race Cars reserves the right to refuse any submission at our sole discretion.
